B2 I also confirm that I have read and fully understood the contents of the attached Form N4 - General Data Protection Regulation EU 2016/679 (GDPR) Declaration Form and declare that I consent to my personal data being processed, under the grounds and for the purpose of this application, and that I have consciously signed the said Form N4 in the appropriate section in acceptance thereof;

B3 I understand that Residency Malta Agency reserves the right to verify any personal information relating to me and may carry out due diligence exercises for the purpose of this application both prior to and following, the granting of such permit;

B4 I understand that Residency Malta Agency does not divulge reasons for refusal or revocation due to the sensitive nature of the due diligence process

B5 I am also aware that during such verification process, Residency Malta Agency may:

- obtain from public sources, government bodies and/or any other kind of records deemed necessary, about me and/or my family and/or my dependants;

B6 I understand that I shall cover the costs for any expenses that are not covered by the health insurance policy for myself and my family members, during the duration of stay in Malta.
